Hispanic Bar Association of Orange County,

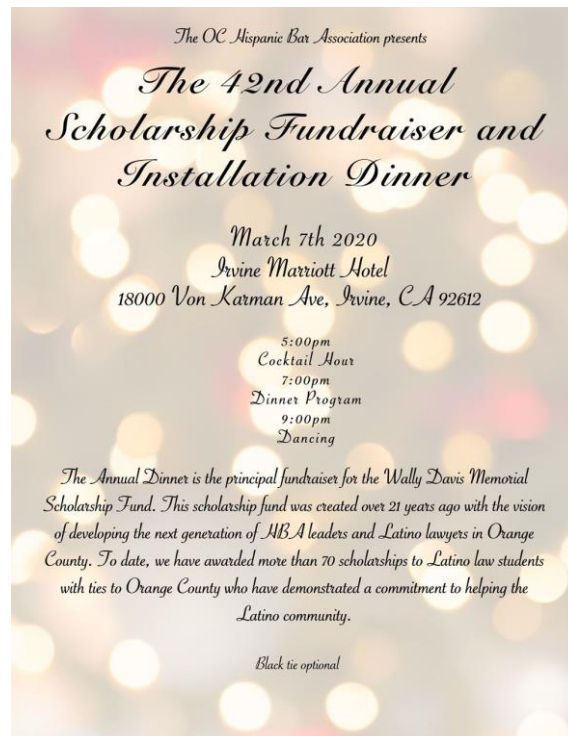
Happy New Year to all! I am honored to serve as this year's President and welcome our new Board of Directors.
